Issues:

- 1. Was the increase in years of service/pension a breach of fiduciary duty?
- Who would have standing to take Council to Court?
- 3. What is the best approach on a go forward basis?

Summary:

- 1. Yes, the payment was a breach of fiduciary duty as it was a marked increase from the previous payment of \$1,000.00 per year, and was a clear and significant personal benefit to the Councillors only, which did not benefit members of the Band.
- 2. Any member of the Band could start an action against Council, as the Band members are beneficiaries and Council acts as a fiduciary. The remedy would likely be and Order that all funds in excess of \$1,000.00 per year get paid back into the Band by those who had received them.
- 3. The best approach on a go-forward basis is to have a plebiscite from the Band members approving this payment

Motion by Mike Stephens to eliminate any and all service honorarium pension plans, retroactive to the very first year of service through to present. Councillors Mike Stephens and Lisa Marshall wish to have their names removed from all funds set aside for pension plans.

Councillor Lisa Marshall would like the cost of the two heat pumps installed in her home to be taken from her honorarium.

<u>Discussion</u>: The heat pumps were chosen to be installed in homes with electric heat, the reason behind this decision was to reduce the cost of electricity. The band is able to offset the costs of the heat pumps from the profits of the windmills. Councillor Lisa Marshall wants to add heat pumps to all the homes. There is concern that this money is for the benefit of all band membership, not only those that live on reserve.
