Questions and Answers From Millbrook Health Centre

Question: Why do I need to wear a mask at the Millbrook Health Centre?

Answer: We ask everyone entering the Millbrook Health Centre to wear a mask to prevent the spread of COVID-19 in our facility.

Question: Why can't I see the doctor/nurse at the Millbrook Health Centre when I already have a doctor somewhere else?

Answer: You are taking an appointment from someone who does have a doctor in this clinic but also the doctor at our clinic does not have your medical file or medication list. Without this information, our doctors would not have all the information they need to do a proper assessment.

Question: Why can't I drop off receipts to the Millbrook Health Centre?

Answer: Due to COVID-19, all bills and receipts are to be placed in an envelope and addressed to the Millbrook Health Centre and dropped off in the MAILBOX outside the Millbrook Band Office. This is to limit the flow of people coming to the Health Centre.

Green Recycling of the Deep Panuke Offshore Gas Platform: Sheet Harbour

Company and Project Overview

RJ MacIsaac Construction Ltd. (RJMI) located in Antigonish since 1975 is a home grown second generation Atlantic Canadian marine construction company. RJMI offers a wide range of services, specializing in marine construction and demolition, ship recycling, tidal power, and general marine contracting.

In early 2020 RJMI made a decision to pursue the recycling contract of the SBM offshore gas platform after the platform had completed its project lifecycle. Competition for this contract was very intense with opposing international bidders. RJMI chances for success were deemed to be remote at best. As well RJMI represented the only opportunity for the rig to be recycled in Nova Scotia. All other bidders indicated that they would transport the rig to their ship yards abroad.

Why Sheet Harbour?

The project requires very deep water all the way to the inshore location to properly (and safely) dismantle the offshore platform. Sheet Harbour has all the attributes and only required a small amount of dredging adjacent to the Sheet Harbour Industrial Wharf (see map below) to facilitate the recycling of the platform.

The offshore rig will be transported from Halifax harbour and positioned inside the "green square" in the picture above. The area required additional dredging to which permitting from DFO was required. In order to secure the



permit RJMI initiated a 7-month engagement process with the Mi'kmaq of Nova Scotia to ensure that the indigenous communities would have input in the development processes as well as fully understand all the additional work RJMI has initiated to ensure that Mi'kmaq Rights and Title are fully protected. RJMI has engaged Mr. Eric Christmas to provide advice and guidance to RJI as well as provide a Mi'kmaq Benefits program.

As Millbrook is not inside the KMKNO process, a separate engagement process with Millbrook's consultation division (led by Gerald Gloade) was also initiated. Millbrook's participation provided additional insights into the local community's capacities and any issues they may have with the project on a local level.

On September 16th, 2020 the Millbrook Consultation division hosted an open house for RJMI in which the full project team and their consultants were able to make presentations on several aspects of the project of which began with RJMI presenting a project overview.

As well presentations on Mi'kmaq Benefits (Eric Christmas), Mi'kmaq archeology (Boreas Heritage), employment opportunities (Grant Thornton) were also included. Pictured below is Sara Beanlands, archeologist, presented her work on Mi'kmaq archeology. (Note: In her report Ms. Beanlands reported that no impacts to indigenous archeology was present as the infill site where the platform will be positioned for recycling is heavily industrialized and no historic material was found).



When will the project start and how long will it take to complete?

RJMI has officially been awarded the contract as of Dec 2020. It is anticipated that the recycling of the platform will take upwards to 18 months with 95% of all materials recycled for future use. RJMI expects the platform (see below) to be towed from the Halifax Harbour very shortly and towed to the Sheet Harbour Industrial Wharf. Soon afterwards the decommissioning of the platform will commence with local labour, including the Mi'kmaq of Nova Scotia.

Mi'kmaq Benefits

RJMI has made a commitment to the Mi'kmaq that a minimum of 33% of all new hires for the project shall be Mi'kmaq. A benefits program was prepared and submitted

Mi'kmaq Offset Project

Included in our permitting is the requirement for an offset project. These projects are very common when proponents are working in marine environments. DFO essentially requires that any potential habitat that might be disturbed or altered must be offset with a habitat restoration project. RJMI has entered (very early) in discussions with the Mi'kmaq Conservation Group (MCG) to ensure that the offset project has the very best in indigenous expertise to assist and advise RJMI with their offset project responsibilities.

It is being proposed that the offset project be located adjacent to (or very close to) Millbrook's fisheries complex in Sheet Harbour. Work on the project should begin in the spring of 2021. MCG will be looking to the local Mi'kmaq communities for labour to construct reef balls (see below) that when placed on a marine floor attracts new marine species and supports habitat growth.



Project Announcement & Participation Opportunity:

Land Use and Occupation Study - Fifteen Mile Stream

Mi'kmaw people have been utilizing land in Nova Scotia for survival and for recreation since time immemorial - without boundaries and without exception. This relationship with the land continues today. Concepts like *Netukulimk* remind us to take only what is needed and leave some for tomorrow, as our ancestors did.


Atlantic Gold is working on developing an open pit gold mining operation in <u>Fifteen</u> <u>Mile Stream</u>. While not on reserve lands, we know that many of our band members have experience harvesting in the area. Band members who have a connection to the area may be affected in terms of their hunting, fishing, and gathering activities, because of the presence of the mine site.


To address these concerns, Millbrook is undertaking a Land Use and Occupation Study. This study will document our history of land use, water use and the stories associated with the area. By doing so, we are preserving our culture and protecting our future. This will also strengthen our claims in future negotiations.

Millbrook is requesting your help to document this important part of our history. You are a vital part of this story. If you, or a family member/friend have harvested (hunting, fishing, camping, etc.) or enjoyed this area please let us know. We will be setting up interviews (either over the phone or Zoom/Teams) to gather land and water usage data to show the project regulators that Millbrook will be impacted.

Our community has received funding to support through the Indigenous Community business fund (ICBF). Under the parameters set aside to spend this money, discretion is given to the community to support COVID-19 economic priorities. Chief and Council have identified a need to support small business owners in our community and have decided to utilize this funding to do so. The total funding pool is \$103,353.00 and will be labelled Small Business Support Fund.

You will find attached an application for our band member owned small businesses who wish to apply for a non-repayable contribution between the amounts of \$500.00 and \$5,000.00. This support is cumulative per household Maximum, and if you own multiple businesses, you do not qualify for each one.

Determination on what level of funding you will receive depends on a pre-determined metric that includes the size of your business measured in sales, number of employees and demonstrated a negative impact on your business due to Covid-19.

The deadline for applications will be March 15th, 2021 or such time that all funds have been spent.

Should all of the funds not be spent by March 15th, 2021, the remaining funds will be directed towards band owned businesses that have also seen a negative impact as a result of COVID-19.
