For Millbrook First Nation members under the age of 19 years, the Millbrook Enterprise Credits are placed in a trust fund. When Millbrook members reach the age of 19, they must apply to Millbrook First Nation to have their Millbrook Enterprise Credit money released from the trust. Please note that as of April 2020, Millbrook First Nation does not automatically receive all information on new registered members so that means that new members under the age of 19 years are not guaranteed to be added to the minor's trust list.

Open Letter to Millbrook Community Members:

I want to update you on the Council's discussions regarding the sale and production of cannabis. We have been informed that the RCMP took some enforcement action against several shops yesterday. My only comment on this is that it was an action not previously known, let alone directed or "signed off" by or directed by myself or Millbrook First Nation Council members.

Millbrook First Nation Council has discussed and debated the economic development potential of cannabis in advance of its legalization in 2018. However, the political cooperation that we had hoped for in order to pursue this for the benefit of the community as a whole has yet to materialize. Since that time, Council has debated and discussed how to advance a cannabis strategy that is respectful of and a benefit to all community members carried out in a way that prioritizes community sovereignty, safety, and well-being of everyone. The survey conducted last year and feedback we have heard through letters and discussions suggested that most community members support the idea of a Millbrook-led cannabis regime and rules around locations, safety, etc. This is consistent with our inherent right to govern and our fiduciary duty to exercise jurisdiction over matters such as the community's health and safety as a whole.

We continue to discuss the development of a cannabis regime and measures necessary for Millbrook First Nation residents' safety and enjoyment of life. Last week we agreed to continue moving in this direction, with several principles and factors to be considered when developing the regulations:

- Keeping cannabis out of the hands of children and youth;
- Maintaining a well-designed and planned community- that means the placement of commercial businesses in certain zones so that it does not interfere with the residents quality of life;
- Ensuring the safety of the community, including traffic control and limitations on hours of business;
- Safe and quality supply of product- knowing where it comes from and the background of suppliers;
- Employment and economic benefits for the collective Millbrook community and;
- Fair opportunities for entrepreneurs within our community.

We appreciate your opinions and ask that you recognize that this is not easy work and is not without risk. It is true that other First Nations communities operate cannabis regimes in other parts of Canada. Still, it is important to understand most of them do so with the support of their provincial governments. This work will take time, and it will be necessary for further engagement with the community.

We have been successful before in working our way respectfully through difficult discussions. Our relatives, past and present, have fought for our rights to manage our affairs and receive collective benefits from tobacco, fishing and gaming. I am confident we will be successful in getting jurisdiction over cannabis as well.



Medical Services at the Health Centre

Millbrook band and community members can access medical services at the community Health Centre by calling to book an appointment with the physician or asking to be assessed by the nurse.

At the Health Centre, patients are triaged according to how sick they are, risks of worsening, and care needs based on their presenting signs and symptoms using a triage system (<u>https://ctas-phctas.ca/</u>) to prioritize patient care.

Therefore, upon calling for assessment or arriving at the Health Centre for an unscheduled appointment, each patient will be asked questions relating to the nature of their visit and a nurse may then do a physical assessment including vital signs.

Based upon the triage nursing assessment, each patient's needs will be cared for in an appropriate manner. The nurse may discharge the patient with instructions including medication, ask the patient to book a follow up appointment, or consult the physician on call.

Millbrook First Nation (MFN) is seeking a self-motivated professional for the fulltime position of a Moderate Livelihood Coordinator for the Millbrook First Nation Fisheries Office location in Millbrook. The Moderate Livelihood Coordinator reports to the Commercial Fisheries Manager and is responsible to work closely with the Fisheries Manager, the Millbrook Community, Chief and Council and other key stakeholders to advance Millbrook's Moderate Livelihood Plan.

Job duties include but are not limited to:

- Work closely with the Fisheries Director, Millbrook First Nation staff and legal counsel, Chief and Council and Community to implement Millbrook's Community Moderate Livelihood Plan.
- Liaise with external key stakeholders (e.g. Other communities, KMKNO Fisheries Team, DFO, Tribal Government).
- Monitor and oversee the updating and implementation of Millbrook's plan.
- Ensure community feedback is used to guide the implementation of Millbrook's Moderate Livelihood Plan.
- Review and analyze data from the community survey results and any engagement sessions held.
- Sensure the plan is consistent with the Assembly's principles.
- Plan and lead community sessions, engaging with interested harvesters and the Community and other key stakeholders as required.
- Provide support to harvesters, identifying challenges and opportunities for improvement and supporting the implementation process.
- Provide regular updates and detailed reports highlighting engagement activities and outcomes, status of development and implementation of the plan to Chief and Council, the Community and other key stakeholders as required.
- Participate in working groups with KMKNO Fisheries team and other community liaisons/coordinators.
- Sestablish approval, compliance and monitoring policies and procedures and ensure other measures such as non-compliance within set provisions of the Millbrook's plan.
- Identify and develop documentation such as application forms and relevant harvesting plan forms and key processes.
- Provide an annual engagement session with community to review the plan.
- Sommunicate, promote, and encourage compliance of the plan.
- Record and report violations to plan provisions to key stakeholders.
- Adhere to Millbrook's policies and procedures as it relates to this position.
- Perform other duties as required.


